PARENT/GUARDIAN WAIVER AND CONSENT

By signing your name at the bottom, you acknowledge that you have read and understand the following disclosure and agree with the terms set forth pertaining to the *Juniata Perry Youth Soccer League*, referenced hereafter as the *JPYSL*:

The *JPYSL* is comprised of: Greenwood, Newport, Richfield, McAlisterville, Mifflintown, Port Royal & Thompsontown. This league is comprised of children ages 4 through 12 with voluntary coaches, concessions workers and field preparatory personnel. The only paid people in the *JPYSL* are the referees at the U10 & U12 levels as mandated by the *JPYSL* by-laws. With this said, it is imperative that the parents of these youth soccer players and all fans attending any *JPYSL* event be cognizant of the voluntary and elementary principles by which this league operates.

Furthermore, the *JPYSL* has adopted in its by-laws a "zero-tolerance policy" against player and spectator misconduct. There is no profanity among coaches, players or fans. This infraction shall be warned or ejected from the vicinity of the field. Tobacco and alcohol are prohibited to be used by any coach, referee or any other volunteer in the presence of a youth player at any *JPYSL* event. In accordance with PIAA and FIFA soccer governance, the referee will have the authority to take disciplinary actions from the moment he/she shows up at the field until the final whistle sounds and he/she departs the playing area.

A lightning strike spotted or the sound of thunder heard will result in an immediate clearing of the area of all players and spectators. Shelter will be sought in a vehicle or under a roof. The game may only resume 30 minutes after the last lightning strike/sound of thunder.

Each youth soccer player is required to wear an appropriate level of equipment (as dictated by the *JPYSL* by-laws) a shirt, shorts and socks with shin guards underneath. Metal cleats are forbidden and the referee will have the final say on all equipment issues.

Each of the six teams in the *JPYSL* has been granted permission by their respective municipality or other similar organization to fully access and utilize certain areas to be designated "home field" for practices and games. However, these municipalities (or other entities) provide this privilege without liability coverage in the event of an injury to your child while on these premises playing organized soccer for the *JPYSL*.

Moreover, each of the teams playing in the *JPYSL* has incorporated an insurance fee with your child's registration fee. This insurance through the *JPYSL* is secondary ONLY to each family's healthcare coverage. This insurance is primarily a safeguard to protect the municipalities and also to limit any liability associated with our youth soccer activities throughout the season.

As the parent or legal guardian of the child named on the registration form, I hereby give my full consent and approval for the child named above to participate as team member on a Greenwood Youth Soccer Team.

I understand that there are certain risks of injury inherent in the practice and play of this sport, as well as in travelling and other related activities incidental, but necessary, to the above named child's participation, and I am willing to assume these risks on behalf of the participant named above. I have read "Heads up Concussion" Fact sheet and understand the risk of concussion.

In addition to giving my full consent for the child's participation, I do hereby waive, release and hold harmless the Greenwood Youth Soccer Association, the Juniata-Perry County Youth Soccer League, its organizers, coaches, sponsors, volunteers and supervisors for any injury that may be suffered by the child in the normal course of participation in the designated sport of soccer and the activities related thereto. Likewise, I release from liability and responsibility the owners of fields and facilities utilized by the sport and any persons transporting the child to and from soccer activities.

I understand the Greenwood Youth Soccer Association, along with the Juniata-Perry County Youth Soccer League, does not carry medical insurance on the player participant named above. As parent/guardian, I understand all medical costs are my responsibility.
